

# OFFICIAL RULES OF THE SC-CUSTOMS CUSTOM CAR RAFFLE

By entering the SC-Customs Custom Car Raffle (the "Raffle"), you consent to be bound by these Official Rules. Accordingly, you should read these rules carefully before entering the Raffle.

1. ORGANIZATION CONDUCTING RAFFLE: The Raffle is being conducted by Sport Compact Customs LLC (SCC), which is solely responsible for the Raffle, the administration of these Official Rules, and the awarding of the prize. Net proceeds from the Raffle will be distributed to SCC.
2. ELIGIBILITY: To be eligible to enter the Raffle, you must comply with these Official Rules.
3. HOW TO ENTER: You have not entered the Raffle until your entry submission, with full payment, has been accepted by SCC. Acceptance of your entry submission will be communicated to you by delivery of a ticket stub or by a written confirmation letter from SCC. If a submission is accepted, then it will be deemed to have been accepted on the date and time on which the submission was received by SCC, regardless of the date that SCC notifies you of the acceptance of your submission. You may enter as often as you want, but all entry requirements must be met for each entry. Tickets will be sold up until 500 entries are accepted. There are 2 ways to submit your entry:
  - a. Submission by Internet: Access the official SCC website at [www.sc-customs.com](http://www.sc-customs.com) ("Raffle Website"), navigate to the Car Raffle entry page, and adding the amount of raffle tickets request to your shopping cart, proceeding to checkout, and completing payment.
  - b. Submission in Person: Purchase your ticket in person from an authorized representative of SCC by completing the official entry form, and handing the completed official entry form, along with a cash or money order to the SCC representative.
4. ODDS OF WINNING: The odds of winning the Grand Prize are 1 out of 500.
  - a. There will be a total of three prizes offered.
    - i. Grand Prize, SCC 2003 Custom Mitsubishi Eclipse GTS
    - ii. 2<sup>nd</sup> Prize - \$500
    - iii. 3<sup>rd</sup> Prize - \$250
5. PROCEDURES FOR LIMITING ENTRIES: The number of entries into the Raffle shall be limited to 500 using the following procedure:
  - a. Submissions received beyond 500 will be refused and, if necessary, entry fees will be returned or refunded.
  - b. SCC shall keep a daily tally of the number of submissions received and accepted, and the date on which they were received. In the event that more than a total of 500 accepted submissions are received, then SCC shall
    - i. determine the day on which 500 accepted admissions were received; and
    - ii. if the daily tally for that day results in there being more than 500 accepted submissions, then
    - iii. SCC shall randomly select from all accepted submissions received that day in order to achieve exactly 500 accepted submissions.
6. METHOD FOR AWARDING GRAND PRIZE: SCC will conduct a drawing for the Grand Prize once 500 accepted submissions are received. You need not be present at the Grand Prize drawing to win. However, the Grand Prize will be available for pickup or delivery to for winning entrant.
7. PRIZES: The prize cannot be substituted by the winner.
8. GENERAL CONDITIONS
  - a. The winner must execute and provide to SCC:
    - i. an Affidavit of Eligibility, attesting to the winner's eligibility and compliance with the Official Rules;
    - ii. a Liability Release, releasing the Sponsors (as defined below) from any liability arising out of the Raffle; and
    - iii. a Publicity Release, allowing SCC to use the winner's name, likeness, voice and biographical information for publicity purposes. The winner also will be required to provide any other information needed by SCC to comply with applicable laws and regulations, including those relating to the payment of income taxes. By accepting a prize, the winner grants SCC permission for the use of his/her name, likeness and biographical information for advertising and promotional purposes without additional compensation, except where prohibited by law.

- b. SCC reserves the right, exercisable upon its sole discretion, to disqualify any individual found to have
    - i. violated these Official Rules;
    - ii. interfered with the entry process or the operation of the Raffle;
    - iii. altered or attempted to alter the random outcome of the Raffle;
    - iv. violated any law or regulation by participating in the Raffle; or
    - v. fraudulently completed the entry form or provided other false information to SCC.
  - c. IN NO EVENT WILL SCC OR ITS BOARD MEMBERS, AGENTS OR EMPLOYEES (COLLECTIVELY, "SPONSORS"), BE LIABLE FOR ANY DAMAGES OR LOSSES OF ANY KIND, INCLUDING DIRECT, INDIRECT, INCIDENTAL, CONSEQUENTIAL, STATUTORY OR PUNITIVE DAMAGES. WITHOUT LIMITING THE FOREGOING, WITH RESPECT TO THE RAFFLE AND TO THE PRIZES, THE SPONSORS MAKE NO WARRANTY OF ANY KIND, EITHER EXPRESS OR IMPLIED, INCLUDING BUT NOT LIMITED TO, THE IMPLIED WARRANTIES OF MERCHANTABILITY OR FITNESS FOR A PARTICULAR PURPOSE.
  - d. All taxes, fees, assessments, title and registration fees, insurance, and like charges, to include delivery costs associated with the receipt or use of the prize are the sole responsibility of the winner. There is no cash value available to the winner of the prize. Vehicle includes custom aftermarket parts which are intended for off-road use only and may not comply with state/local laws and are deemed for "show" purposes only.
  - e. The Sponsors assume no responsibility for changes in market conditions that may impact the value of the prize. There is no guaranty that a winner will be able to sell the prize for the estimated value or that the IRS, or its counterpart in any state's jurisdiction, will accept the value of the prize for purposes of determining any tax that may be due by the winner. Insured value of Grand Prize is \$42,500 by Haggerty Insurance.
  - f. Entrants hereby fully release the Sponsors from any and all liability caused by or resulting from the use or possession of any prize awarded or caused by or resulting from participation in the Raffle or any related promotion.
  - g. SCC assumes no responsibility for lost, late, misdirected or undelivered entry submissions, or any error, delay, or interference with entry via the Raffle Website.
9. EXTENSION OF RAFFLE: At SCC's sole discretion and option, the dates for any of the drawings may be extended by no more than thirty days.
10. DISPUTE RESOLUTION: Venue of any action brought concerning the Raffle shall be in Fairfax, VA, and shall not be subject to transfer to another venue or locale for any reason. By entering the Raffle, you agree that you will not commence or participate in any class action litigation, or join with any other person in a legal proceeding, concerning the Raffle. The Raffle, these Official Rules, the entire relationship between you and SCC, and any legal proceeding arising there from (whether based on contract, tort, law or equity), shall be governed by, construed in accordance with, and enforced pursuant to, the laws of the Commonwealth of Virginia, without regard to its conflict of laws principles.
11. AMENDMENT OF RULES: If, for any reason, the administration, security, fairness, or integrity of the Raffle has been compromised, SCC reserves the right, exercisable at its sole discretion, to cancel, terminate, modify or suspend the Raffle. The Official Rules may be amended by SCC in its sole discretion. Amendments will be posted on the Raffle Website. Unless otherwise specified, any amendments will become effective at 12:00:01 a.m. EST on the day after they are posted on the Raffle Website.
